FALL 2017 NEWSLETTER

Important Stodge Meadow Association (SMA) Dates in 2017 & 2018: <u>September 30</u> – Ten Year Phase 1 Dam Safety Re-inspection Completed <u>November 1</u> – Annual water level drawdown begins <u>July 13, 2018</u> – Annual SMA Membership Meeting – 7:30 PM – Tentatively to be held at the Ashburnham Community Church (same place as last year)

Fall Drawdown & Spring Recharge: The Fall Drawdown will begin November 1st, and the pond should return to "full pool" on or about next April 1st. Our continued thanks to **Mickey Gillis** for removing and reinstalling the spillway boards plus taking weekly readings.

Dues Update: As of this newsletter, we have received dues payments from <u>ALL</u> of our usual dues-paying members; unfortunately, there continue to be <u>six former</u> members who have not paid and, therefore, cannot use the pond!! We are very grateful to all members, because these dues make running our association much easier. Please plan on making your Fiscal 2019 dues payment in July at the Annual Membership Meeting.

Fall Dam Inspection & Maintenance: We hired Trowbridge Engineering which is a local professional engineering firm and is certified by the State to do Dam Safety Inspections. They have submitted the report to the State Department of Conservation and Recreation (DCR). As soon as the final inspection report is available to SMA, I will send out that information. This Fall Denis Maguy, Mickey Gillis, and Paul Bassett/Don Leger will add 20 to 60 additional yards of rip rap to the upstream side of the dam which will help resolve one finding in the inspection report. To resolve another finding, all blueberry bushes have been removed from the pond side of the dam. The SMA Board will be thoroughly examining the final report and will cost out the work that needs to be done. This last effort will be completed before the July 2018 Annual Meeting.

Ashburnham Lakes Coalition (ALC): Member ponds and lakes are Billy Ward Pond, Lake Winnekeag, Little Watatic Pond, Lake Watatic, Lower Naukeag, Sunset Lake, and Stodge Meadow Pond. The ALC continues to provide the SMA with additional funds from boat registration fees paid to the State. Over the past three years SMA has averaged slightly more than \$500 per year in additional revenue which has helped to offset our expenses for various maintenance and repair projects.
